
The department continues to seek ways to be more service friendly, helpful and find new ways to assist the charities in maintaining compliance. The department staff is committed to enhancing and improving our outreach efforts and is here to help charities with questions, concerns, or issues that may arise. In FY 2011, the Department of Charitable Gaming operating budget information and comparative information to previous years is as follows: The Department of Charitable Gaming is required by statute to be self-supporting through a fee collected on gross gaming receipts paid by more than 658 Kentucky Licensed Charitable Gaming Organizations, while an additional 619 licenses are classified as exempt because they earn below \$25,000 annually. Effective July 1, 2007, KRS 238.570 was amended to allow adjustment to this fee based on annual gross receipts by October 1 of each odd-numbered year.



Gross Receipts

In 2011, charitable gaming players spent more money on charitable gaming than wagered on horseracing in Kentucky. Of the three types of legalized gaming in Kentucky, charitable gaming received over \$392.5 million in gross receipts, or 25.6 percent of the dollars wagered. The Kentucky Lottery had the largest amount of gaming revenue, capturing approximately \$772.3 million, or 50.4 percent in gross receipts, while horseracing wagered receipts were approximately \$366.5 million, or 23.9 percent.




- The gross receipts of a charitable gaming organization are defined as the money taken at the door before payouts or expenses are deducted. In 2011, the gross receipts for Kentucky's charitable gaming organizations were \$392,530,562.90

Retention Percentage

Kentucky has a 40 percent rentention percentage that by law must be retained for charitable purposes by the charities. The retention percentage (money available for charities to be used) was 63.19 percent in 2011.



Charitable Organizations/Types of Licensees

The Department of Charitable Gaming licenses not only charitable organizations, but also the manufacturers of gaming supplies, distributors of gaming supplies, and the facilities in which charitable gaming occurs. Charitable gaming organizations include churches, schools, bands, sports programs, veterans groups, fire and rescue departments, arts organizations, animal welfare groups, history or museum organizations, and others.

In order to qualify for a gaming license, an organization must have an IRS 501(c)(3), (4), (8), (10), or (19) exempt organization status, or be a school, institution of higher education, or state college or university. Since the department's creation, one-third of charitable gaming licensees are Catholic charities (churches, schools, or men's groups). Organizations associated with military veterans make up the second largest group of licensees. Together, these two groups account for approximately half of Kentucky's 1,277 licensed charitable gaming organizations, 658 licensed organizations and 619 exempt licenses in 2011.

Audit Branch

The Audit Branch of the Kentucky Department of Charitable Gaming is located within our Enforcement Division. The Audit Branch offers assistance to charitable gaming organizations with the accurate reporting of their charitable gaming operations and proceeds.

This is done by:

- Training, to ensure that gaming organizations are as thoroughly familiar as possible with the gaming regulations and statutes.
- Reporting, to assist charities with the accurate reporting of the results of their gaming operations and the remittance of the fee due based on the gross receipts generated by those operations.
- Audits, examining the financial records of a charity to ensure that all statutory and regulatory requirements have been met.

In 2011:

- 43 of the 86 audits opened and assigned were closed in 2011.
- 23 audits opened in 2010 were closed in 2011.
- 5 audits opened in 2009 were closed in 2011.

Investigative Branch

The Investigative Branch is part of the Enforcement Division. The main function of this branch is to investigate complaints of criminal wrong doing regarding charitable gaming within the Commonwealth of Kentucky.

The Investigative Branch of the Department of Charitable Gaming's management staff is comprised of one director of enforcement and one investigator manager who reports directly to the director of enforcement. In fiscal year 2011, there were five investigators assigned to the Enforcement Division. These investigators main duties are focused on investigating complaints and/or alleged criminal wrongdoing and are located throughout the Commonwealth of Kentucky. The criminal allegations may include theft, criminal possession of a forged instrument, promoting gambling, possession of gambling devices, participation in a continuing criminal enterprise, tax evasion and money laundering.

The Investigative Branch works hand in hand with our Audit Branch as well as with local, state and federal law enforcement agencies, joint task force and prosecutors in order to enhance the investigation of criminal charitable gaming cases. In 2011, the department implemented the use of barcode scanners which have been incorporated into the investigative process and they have been proven to be an effective tool.

Of the 69 cases opened in 2011, 50 cases have been closed. Of the remaining 19 cases, five are pending final audits, three cases are related and being investigated as a single case, three are being prosecuted in court, two are in the final stages to be presented to the grand jury with the remaining six cases still under active investigation.

Legal Branch

The Legal Branch of the Department of Charitable Gaming continued its efforts to streamline the legal processes available to charities to resolve outstanding violations. The branch partnered with other staff within the agency, and substantially reduced its case backlog. Staff also strived to reduce the time between violation occurrence and notice of violation issuance to 30 days. This quicker notice to charities allowed our licensees to correct financial reporting problems in a timely manner, and resulted in a substantial reduction in fines and increase in compliance with regulatory requirements. The Legal Branch issued 324 Notices of Proposed Administrative Action in 2011. We received 69 appeals in 2011, down from 197 in 2010. We resolved almost all of these appeals by settlement agreement.

Accounting Division

In FY 2011, the Accounting Division strived to review financial reports quickly and as accurately as possible. This has allowed the majority of caution letters to be issued and errors resolved before the next reporting period is due. With that said, there are fewer violations in subsequent reporting periods. Also, this has created fewer fines for our charities. With help from the Licensing Branch, the Accounting Division has initiated a review to help charities with their reporting requirements of special charity gaming events, special limited charity fundraising events and raffles. In FY 2011, the Accounting Division continued the process of collecting outstanding fees, fines and responses before the license renewal is issued. This has resulted in easier renewal process and collection processes. Our staff continues to strive with all licensees to assure compliance with all statues and regulations related to financial reporting.
