RE: **PROPOSED AMENDMENTS TO 810 KAR 7:040**

The Kentucky Horse Racing Commission recommends the following proposed amendments to 810 KAR 7:040: Kentucky Standardbred Development Fund and Kentucky Standardbred Breeders' Incentive Fund. This version of proposed amendments includes suggested edits from the group.

1. Amend the definition of "Kentucky-bred" in Section 1 as follows:

- (4) "Kentucky-bred" means a standardbred horse that is:
 - (a) Foaled out of a standardbred mare that is registered with the commission [~~and meets the requirements of this administrative regulation~~]; or
 - (b) Sired by a standardbred stallion standing [~~residing~~] in Kentucky that is registered with the commission [~~that meets the requirements of this administrative regulation~~].

This proposed amendment removes the phrase "and meets the requirements of this administrative regulation." This allows 810 KAR 5:080: Kentucky Proud Series to use the term "Kentucky-bred" in its participation requirements for the Kentucky Proud Series, without requiring Kentucky Proud Series horses to conform to other requirements in 810 KAR 7:040, such as nomination and sustaining fees.

The amendment also removes the term "residing" and substitutes the correct term "standing."

Additionally, the amendment clarifies that the stallion has to be registered with the Commission to sire a Kentucky-bred foal. This matches the requirements for mares.

2. Amend the definition of "Stallion residing in Kentucky" as follows:

- (8) "Stallion standing [~~residing~~] in Kentucky" means a stallion physically located and standing in Kentucky for 180 days of the calendar year in which the stallion is registered with the commission that[;] does not service mares in any other state[~~, jurisdiction, or country~~] outside Kentucky during the calendar year in which the stallion is registered.

This proposed amendment removes the term "residing" and substitutes the correct term "standing."

The amendment also clarifies that the stallion must be registered with the Commission.

Additionally, the amendment clarifies the Panel and the Commission's intent for this regulation, by removing confusing language indicating that a stallion shall not service mares in any jurisdiction or country outside of Kentucky when the stallion is registered.

3. Clarify a foal's eligibility requirements for the Sire Stakes as follows:

(1) In order to qualify for the Kentucky Sire Stakes, a foal shall be a two (2) or three (3) year old Kentucky-bred and shall maintain eligibility for the KSDF and KSBIF as established in Sections 16, 19, and 20 of this regulation.

This proposed amendment clarifies that a foal shall maintain its eligibility, as established in Sections 16, 19, and 20 of 810 KAR 7:040.

4. Clarify the Panel and the Commission's intent for participating stallions as follows:

Notwithstanding the foregoing, semen from a stallion standing in Kentucky may be shipped to mares in any jurisdiction outside of Kentucky at any time during the calendar year in which the stallion is registered. Additionally, a registered stallion may shuttle to countries in the Southern Hemisphere to service mares, provided the stallion meets all other standing requirements. But, a registered stallion shall not service mares in any country, other than the United States or countries in the Southern Hemisphere by way of shuttle. Also, a registered stallion shall not shuttle to any state or jurisdiction in North America, other than Kentucky, in order to service mares. The changes in this subsection are effective starting with the 2020 breeding season and in subsequent years.

This proposed amendment clarifies the intent of the Panel and the Commission by stating that a stallion standing in Kentucky may ship semen to mares in any jurisdiction outside of Kentucky during the calendar year in which he is registered.

Additionally, the amendment states that a stallion may shuttle to any countries in the Southern Hemisphere to service mares, provided the stallion meets all other standing requirements. However, the amendment does not allow participating stallions to service mares in any other country, other than the United States or countries in the Southern Hemisphere, by way of shuttle. Furthermore, stallions shall not shuttle to any location in North America, other than Kentucky, in order to service mares.

Of note, this provision is retroactive to the 2020 breeding season, in order to ensure that the Standardbred incentive program is consistent with other breeds and to bring the regulation's language into conformity with KHRC practices.

The KHRC staff recommends the above proposed amendments.

14 offered for the conduct of any horse race meeting. KRS 230.770(1) establishes the
15 Kentucky standardbred development fund. KRS 230.770(6) and (7) authorize the
16 commission to promulgate administrative regulations establishing the eligibility of horses
17 participating in races for which a portion of the purse is provided by the Kentucky
18 Standardbred Development Fund and the conditions, class, and quality of the races. KRS
19 230.802(1) establishes the Kentucky standardbred breeders' incentive fund. KRS
20 230.802(2)(b) requires the commission to promulgate administrative regulations

1 establishing the conditions and criteria for the distribution of moneys from the fund. This
2 administrative regulation establishes eligibility standards, administrative practices to
3 enforce the standards, criteria for the distribution of moneys from these funds, mandatory
4 criteria for races, and the administration of purses and payments in these races.

5 Section 1. Definitions.

6 (1) "Commission" means the Kentucky Horse Racing Commission.

7 (2) "Consolation" means the race following a series of preliminary legs for the next
8 preferred horses, as established in Section 6 of this administrative regulation, which did
9 not qualify for the finals of each racing division of the Kentucky Sire Stakes program.

10 (3) "Final" means the race following a series of preliminary legs established to determine
11 the divisional champion of each racing division of the Sire Stakes Program.

12 (4) "Kentucky-bred" means a standardbred horse that is:

13 (a) Foaled out of a standardbred mare that is registered with the commission [~~and~~
14 ~~meets the requirements of this administrative regulation~~]; or

15 (b) Sired by a standardbred stallion standing [~~residing~~] in Kentucky that is registered
16 with the commission [~~that meets the requirements of this administrative regulation~~].

17 (5) "Kentucky Sire Stakes" means the series of races held annually in Kentucky for two
18 (2) and three (3) year old Kentucky-bred fillies and colts, both trotting and pacing, and
19 funded in whole or in part by the Kentucky Standardbred Development Fund or the
20 Kentucky Standardbred Breeders' Incentive Fund.

21 (6) "KSBIF" means the Kentucky Standardbred Breeders' Incentive Fund as established
22 in KRS 230.802.

1 (7) "KSDF" means the Kentucky Standardbred Development Fund as established in
2 KRS 230.770.

3 (8) "Stallion standing [~~residing~~] in Kentucky" means a stallion physically located and
4 standing in Kentucky for 180 days of the calendar year in which the stallion is registered
5 with the commission that[~~;~~] does not service mares in any other state[~~, jurisdiction, or~~
6 ~~country~~] outside Kentucky during the calendar year in which the stallion is registered.

7 (9) "USTA" means the United States Trotting Association.

8 Section 2. Domicile Requirements.

9 (1)

10 (a) An owner, lessee, stallion manager, or syndicate manager of a standardbred stallion
11 residing in Kentucky who desires to use the stallion to breed and to have his progeny
12 eligible for the KSDF or KSBIF shall register the stallion with the commission by
13 December 31st of the year of conception of the horse sought to be eligible by
14 submitting a completed "KSDF/KSBIF Stallion Certificate of Eligibility Form", KHRC 7-
15 040-2.

16 (b) Standardbred stallions not residing in Kentucky are not required to register with the
17 commission. The progeny of a standardbred stallion not residing in Kentucky is not
18 eligible for the KSDF or KSBIF unless the progeny is that of a standardbred mare
19 registered under and meeting the requirements of this administrative regulation.

20 (c) All standardbred stallions shall be registered with the USTA, Standardbred Canada,
21 or other appropriate international harness racing governing agency whether residing
22 in Kentucky or not.

23 (2)

1 (a) An owner, lessee, manager, or syndicate manager of a standardbred mare who
2 desires to use the mare for breeding purposes and to have her progeny eligible for the
3 KSDF or KSBIF shall register the mare by December 31st of the year of conception of
4 the horse sought to be eligible by submitting a completed "KSDF/KSBIF Mare
5 Certificate of Eligibility Form", KHRC 7-040-3.

6 (b) To be eligible for registration, the mare shall:

- 7 1. Be registered with the USTA, Standardbred Canada, or other appropriate
8 international harness racing governing agency; and
- 9 2. Have resided in Kentucky for a period of not less than 180 days in the calendar
10 year of conception of the horse sought to be eligible.

11 (c) If a horse is conceived by embryo and ovum transplant (ET), both the donor mare
12 and recipient mare shall be registered during the year of conception, and the recipient
13 mare shall reside in Kentucky for a period of not less than 180 days in the calendar
14 year of conception of the horse sought to be eligible.

15 (3) Registrations shall be received by the commission by the close of business or
16 postmarked on the deadline established in this section in order to be eligible.

17 (4) An owner, lessee, stallion manager, manager, or syndicate manager of a stallion or
18 mare eligible for the KSDF and KSBIF shall be responsible for:

19 (a) The registrations and records of the farm where the stallion stands or the mare
20 resides; and

21 (b) Complying with all applicable requirements of this administrative regulation.

22 Section 3. Eligibility.

1 (1) In order to qualify for the Kentucky Sire Stakes, a foal shall be a two (2) or three (3)
2 year old Kentucky-bred and shall maintain eligibility for the KSDF and KSBIF as
3 established in Sections 16, 19, and 20 of this regulation.

4 (2) Notwithstanding the foregoing, semen from a stallion standing in Kentucky may be
5 shipped to mares in any jurisdiction outside of Kentucky at any time during the calendar
6 year in which the stallion is registered. Additionally, a registered stallion may shuttle to
7 countries in the Southern Hemisphere to service mares, provided the stallion meets all
8 other standing requirements. But, a registered stallion shall not service mares in any
9 country, other than the United States or countries in the Southern Hemisphere by way
10 of shuttle. Also, a registered stallion shall not shuttle to any state or jurisdiction in North
11 America, other than Kentucky, in order to service mares. The changes in this subsection
12 are effective starting with the 2020 breeding season and in subsequent years.

13 (3)

14 (a) Except as provided by paragraph (b) of this subsection, only a foal that is the first
15 born to a mare (donor or recipient) in each calendar year produced by any method,
16 including embryo and ovum transplant (ET), shall be eligible for the Kentucky Sire
17 Stakes.

18 (b) Natural birth twins produced from the same pregnancy and foaling by the natural,
19 nonrecipient mare shall also be eligible.

20 (3) Any future offspring of foals ineligible for racing under this section shall be ineligible
21 for the Kentucky Sire Stakes.

22 Section 4. Distance. Each Kentucky Sire Stakes race shall be a one (1) mile dash.

1 Section 5. Post Positions. Post positions for the final, consolation, and all preliminary legs
2 of the Kentucky Sire Stakes race shall be an open draw with two (2) horses drawn for the
3 final and consolation races that are designated as "also eligibles" under Section 6(7) of
4 this administrative regulation.

5 Section 6. Eligibility for the Final and Consolation Races.

6 (1) Beginning with the 2018 Kentucky Sire Stakes races, consolation races may be
7 eligible for funding.

8 (2) A horse that does not start in at least one (1) of the preliminary legs scheduled shall
9 not be eligible for the final or consolation.

10 (a) All horses earning points may enter in the final with:

11 1. The top eight (8) point earners, if the horses raced on a half (1/2) mile track or five-
12 eighths (5/8) mile track; or

13 2. Top ten (10) point earners, if the horses raced on a one (1) mile track, to be
14 declared eligible.

15 (b) On a half (1/2) mile track or five-eighths (5/8) mile track, the top eight (8) point
16 earners shall not be eligible for the consolation. On a one (1) mile track, the top ten
17 (10) point earners shall not be eligible for the consolation.

18 (c) A horse that is eligible to race in the final shall only be eligible to race in the final,
19 unless the horse is qualified as an also eligible.

20 (d) A horse that is eligible to race in the consolation shall only be eligible to race in the
21 consolation, unless qualified in the final as an also eligible.

22 (e) A horse that scratches from the final shall not race in the consolation.

1 (f) A horse that has qualified for the final or consolation shall remain eligible for the final
2 or consolation.

3 (g) At least seven (7) eligible horses shall be declared for a consolation race to be
4 contested.

5 (h) A horse that is automatically eligible to race in the final race shall not start in the
6 consolation race.

7 (3) A horse that enters a preliminary leg that does not fill and is not raced shall receive
8 credit toward fulfilling the minimum starting requirements established in subsection (2)
9 of this section and toward determining tiebreaker status as established in subsection
10 (6)(b) of this section.

11 (4) A horse that has been scratched from an event that is raced shall not receive credit
12 toward meeting the starting requirements established in subsection (2) of this section.

13 (5) A horse, in order to start in the final or consolation, shall be declared at the host track
14 where the race is being held on or before the time posted on the track condition sheet.

15 (6)

16 (a) If the number of horses eligible and declared into any final or consolation event
17 exceeds the maximum number specified by the KSDF or KSBIF or the number of
18 positions on the starting gate, the following point system as applied to KSDF
19 preliminary legs shall determine preference for the final:

- 20 1. 1st place - fifty (50) points;
- 21 2. 2nd place - twenty-five (25) points;
- 22 3. 3rd place - twelve (12) points;
- 23 4. 4th place - eight (8) points;

1 5. 5th place - five (5) points;

2 6. 6th place and all other starters - one (1) point; and

3 7. A horse finishing in a dead heat for any position in a preliminary leg shall be

4 awarded an equal share of the total number of points awarded for that position.

5 (b) If there is a tie among horses after the awarding of points pursuant to paragraph

6 (a) of this subsection, there shall be a drawing by lot among those horses tied in total

7 points to determine which horses shall be included in the final field.

8 (c) If a horse that is qualified for the final or consolation is not declared, the horse with

9 the next highest point total, pursuant to paragraph (a) of this subsection, that is

10 declared shall be eligible for the final or consolation.

11 (7) Also eligibles.

12 (a) The two (2) horses accumulating the highest point total, pursuant to subsection (6)

13 of this section, that are declared into the final or consolation, but do not qualify for the

14 final or consolation, shall be designated "also eligible". The horse with the highest point

15 total from the preliminary legs shall be designated as the "first also eligible" and the

16 horse with the next highest point total shall be designated as the "second also eligible".

17 (b) A horse that is scratched in the final or consolation shall be replaced by the "first

18 also eligible" and then the "second also eligible", if necessary.

19 1. If post positions have not been drawn at the time of the scratch, the "also eligible"

20 shall take the place of the horse that has been scratched and shall participate in the

21 normal draw.

22 2. If post positions have been drawn at the time of the scratch, the "also eligible" shall

23 assume the post position of the horse that has been scratched.

1 3. A horse shall not be moved into the final or consolation as a replacement after the
2 official scratch time deadline that is in effect at the host track.

3 Section 7. Final Order of Finish. The judges' "official order of finish" shall be used in
4 determining eligibility to the final exclusive of all appeals yet to be decided at the time of
5 closing of the entry box for final events.

6 Section 8. Detention. All starters shall be subject to the detention policy of the racetrack.

7 Section 9. Number of Starters.

8 (1) There shall not be more than:

9 (a) Ten (10) starters in each final race on a one (1) mile track; and

10 (b) Eight (8) horses on a one-half (1/2) or five-eighths (5/8) mile track.

11 (2) All horses shall be on the gate for the final race.

12 Section 10. Declaration Fees.

13 (1) For each horse declared to race in a preliminary leg, there shall be a declaration fee
14 of one-half of one percent (0.5%) of the total purses distributed or to be distributed for
15 each race in which the horse is declared.

16 (2) The declaration fee shall be due to the racing association at the time of declaration
17 and payable one (1) hour prior to post time of the race.

18 (3) Purses for the KSDF and KSBIF shall consist of money from:

19 (a) Nominating fees;

20 (b) Sustaining fees;

21 (c) Declaration fees; and

22 (d) Added money from the Commonwealth of Kentucky.

23 (4)

1 (a) Distribution of revenue for Kentucky Sire Stakes races shall be reviewed and
2 addressed annually, not later than December 15 of each calendar year, by an advisory
3 panel appointed by the Chairman of the commission and consisting of one (1)
4 representative from each of the following:

- 5 1. The commission, who shall serve as the chairman of the panel;
- 6 2. The Kentucky Harness Horseman's Association;
- 7 3. The Kentucky Harness Association;
- 8 4. The host racetrack; and
- 9 5. One (1) participant in the fund nominated by the chairman of the commission from
10 a group of up to four (4) nominees recommended by each of the above four (4)
11 members having one (1) nomination each.

12 (b) Each member of the panel shall serve from July 1 through June 30 of the following
13 year and shall be a resident of Kentucky.

14 (c) The final determination regarding distribution of revenue shall be made by the
15 commission.

16 Section 11. Divisions of Preliminary Legs.

17 (1) The total number of horses entered shall determine the number of divisions of the
18 preliminary legs that shall be required.

19 (2) Preliminary legs shall be split into divisions as follows:

20 (a) One (1) mile track:

- 21 1. Twelve (12) horses or less entered - one (1) division race.
- 22 2. Thirteen (13) to twenty (20) horses entered - two (2) divisions.
- 23 3. Twenty-one (21) to thirty (30) horses entered - three (3) divisions.

- 1 4. Thirty-one (31) to forty (40) horses entered - four (4) divisions.
- 2 5. Forty-one (41) to fifty (50) horses entered - five (5) divisions.
- 3 6. Fifty-one (51) to sixty (60) horses entered - six (6) divisions.
- 4 (b) One-half (1/2) and five-eighths (5/8) mile track:
- 5 1. Nine (9) to ten (10) horses entered - one (1) division.
- 6 2. Eleven (11) to sixteen (16) horses entered - two (2) divisions.
- 7 3. Seventeen (17) to twenty-four (24) horses entered - three (3) divisions.
- 8 4. Twenty-five (25) to thirty-two (32) horses entered - four (4) divisions.
- 9 5. Thirty-three (33) to forty (40) horses entered - five (5) divisions.
- 10 6. Forty-one (41) to forty-eight (48) horses entered - six (6) divisions.
- 11 (c) If the need exists for seven (7) or more divisions, eligibility to the final shall be
- 12 determined in a manner consistent with the published conditions.
- 13 Section 12. Gait.
- 14 (1) Gait shall be specified by the owner of the horse on or before the first two (2) year
- 15 old payment.
- 16 (2)
- 17 (a) Change of gait may be made at the time of declaration at the track.
- 18 (b) Sustaining payments shall remain in the funds of the original gait specified.
- 19 (3) A horse shall not race on both gaits in the same year.
- 20 Section 13. Divisions. A race shall be raced in separate divisions as follows:
- 21 (1) Colt, gelding, ridgeling divisions; and
- 22 (2) Filly divisions.
- 23 Section 14. Purse Distributions.

1 (1) The purses awarded for all races shall be distributed on the following percentage
2 basis:

3 (a) Five (5) starters - fifty (50) percent, twenty-five (25) percent, twelve (12) percent,
4 eight (8) percent, and five (5) percent;

5 (b) Four (4) starters - fifty (50) percent, twenty-five (25) percent, twelve (12) percent,
6 eight (8) percent, and the remaining five (5) percent reverts back to the fund;

7 (c) Three (3) starters - fifty (50) percent, twenty-five (25) percent, twelve (12) percent,
8 and the remaining thirteen (13) percent reverts back to the fund;

9 (d) Two (2) starters - fifty (50) percent, and twenty-five (25) percent, and the remaining
10 twenty-five (25) percent reverts back to the fund; and

11 (e) One (1) starter - fifty (50) percent, and the remaining fifty (50) percent reverts back
12 to the fund.

13 (2) The percentage basis established by subsection (1) of this section shall apply at
14 each of the Kentucky pari-mutuel tracks.

15 Section 15. Cancellations.

16 (1) If circumstances prevent the racing of an event and the race is not drawn, all funds
17 allocated to the division in each of the preliminary legs or the final shall be refunded and
18 prorated to the owners of the horses eligible at the time of cancellation.

19 (2) The eligible horses shall include only horses that made the payments required by
20 Section 20 of this administrative regulation.

21 (3) The added monies provided by the Commonwealth of Kentucky for use in the KSDF
22 and KSBIF shall be disbursed by December 15 of each calendar year in accordance

1 with the formula created by the panel as set out in Section 10(4) of this administrative
2 regulation.

3 Section 16. Qualifying.

4 (1) Any horse declared into a Kentucky Sires Stakes race shall:

5 (a) Show at least one (1) charted race line with no breaks within forty-five (45) days
6 prior to the day of the race; and

7 (b) Have satisfied the following time requirements:

8 1. On a track larger than five-eighths (5/8) of a mile:

9 a. A two (2) year old trotter shall have been timed in two minutes and six seconds
10 (2:06) or faster;

11 b. A two (2) year old pacer shall have been timed in two minutes and four seconds
12 (2:04) or faster;

13 c. A three (3) year old trotter shall have been timed in two minutes and two seconds
14 (2:02) or faster; and

15 d. A three (3) year old pacer shall have been timed in two minutes and zero seconds
16 (2:00) or faster.

17 2. On a five-eighths (5/8) mile track:

18 a. A two (2) year old trotter shall have been timed in two minutes and seven seconds
19 (2:07) or faster;

20 b. A two (2) year old pacer shall have been timed in two minutes and five seconds
21 (2:05) or faster;

22 c. A three (3) year old trotter shall have been timed in two minutes and three seconds
23 (2:03) or faster; and

1 d. A three (3) year old pacer shall have been timed in two minutes and one second
2 (2:01) or faster.

3 3. On a one-half (1/2) mile track:

4 a. A two (2) year old trotter shall have been timed in two minutes and eight seconds
5 (2:08) or faster;

6 b. A two (2) year old pacer shall have been timed in two minutes and six seconds
7 (2:06) or faster;

8 c. A three (3) year old trotter shall have been timed in two minutes and four seconds
9 (2:04) or faster; and

10 d. A three (3) year old pacer shall have been timed in two minutes and two seconds
11 (2:02) or faster.

12 (2) A horse shall be scratched from a race if the person declaring the horse has failed to
13 advise the race secretary of a start that is not reflected on the electronic eligibilities.

14 (3) The requirements of this section shall apply both to wagering and nonwagering
15 races.

16 Section 17. Purse Allocations.

17 (1) At a scheduled meeting of the commission, the commission shall:

18 (a) Establish the distribution of funds for stakes races for the upcoming year; and

19 (b) Authorize expenditures at a time it designates.

20 (2) The racing dates for KSDF and KSBIF stakes shall be issued after the track has
21 established its race dates.

22 Section 18. Promotions. The KSDF or KSBIF may provide a trophy for each event, and
23 the program that provides the trophy shall purchase the trophy out of its fund.

1 Section 19. Nomination Fees.

2 (1) After payment of the mare or stallion nomination fee, foals shall remain eligible for
3 events each year by making the required sustaining and declaration payments for that
4 year, as set forth in Section 20. The "KSDf/KSBIF Kentucky Sire Stakes (KYSS)
5 Nomination Form," KHRC 7-040-1, shall be filed with the commission along with the
6 nomination and sustaining fees.

7 (2) After payment of the yearling nomination fee, foals shall remain eligible for events
8 each year by making the required sustaining and declaration payments for that year, as
9 set forth in Section 20. The "KSDf/KSBIF Kentucky Sire Stakes (KYSS) Nomination
10 Form," KHRC 7-040-1, shall be filed with the commission along with the nomination and
11 sustaining fees.

12 (3) The two (2) year old March 15 payment shall be made to remain eligible to the KSDf
13 and KSBIF as a three (3) year old without penalty, except as provided in Section 20.

14 (4) Nomination and sustaining payments shall be made to the KSDf and KSBIF in U.S.
15 funds by a money order or a check drawn on a U.S. bank account.

16 Section 20. Nomination Schedule.

17 (1) Mares or Stallions shall be nominated by December 31 of the year of conception of
18 the horse sought to be eligible by submitting a completed "KSDf/KSBF Stallion
19 Certificate of Eligibility Form," KHRC 7-040-2, or "KSDf/KSBF Mare Certificate of
20 Eligibility Form," KHRC 7-040-3. The nomination fee shall be set forth in KHRC 7-040-2
21 or 7-040-3, except as provided in subsection (4) of this section.

22 (2) For yearlings sired by a standardbred stallion or mare that resided in Kentucky during
23 the year of conception for a period no less than 180 days and registered with the KSDf

1 and KSBIF, the nomination fee shall be set forth in the "KSDF/KSBIF Kentucky Sire
2 Stakes (KYSS) Nomination Form," KHRC 7-040-1, except as provided in subsection (5)
3 of this section.

4 (3) Nominated horses shall be registered with the USTA, Standardbred Canada, or other
5 appropriate international harness racing governing agency and shall be properly
6 identified to the satisfaction of the commission at the time of the nomination.
7 Identification shall be determined by the official registration maintained by the USTA,
8 Standardbred Canada, or other appropriate international harness racing governing
9 agency.

10 (4) If a mare is not nominated to the KSDF and KSBIF by December 31 of the year of
11 conception, the mare shall be nominated by submitting a KSDF/KSBIF Application for
12 Late Mare Registration, KHRC 7-040-4, and paying a penalty as set forth in KHRC 7-
13 040-4.

14 (5) If a horse sired by a standardbred stallion or mare that resided in Kentucky during
15 the year of conception, for a period no less than 180 days, and registered with the KSDF
16 and KSBIF is not nominated during its yearling year, the horse may be nominated by
17 March 15 of its two (2) year old year by submitting the "KSDF/KSBIF Kentucky Sire
18 Stakes (KYSS) Nomination Form," KHRC 7-040-1, and paying a penalty as set forth in
19 KHRC 7-040-1.

20 (6) For three (3) year old horses that fail to make the mandatory March 15 two (2) year
21 old sustaining payment, the horse may be nominated by February 15 of its three (3) year
22 old year by submitting a KHRC 7-040-1 and paying a penalty as set forth in KHRC 7-
23 040-1.

1 Section 21. Early Closing Events. The commission may provide for separate early closing
2 events for Kentucky-bred horses.

3 Section 22. Stallion and Breeder Awards. The commission may provide for stallion and
4 breeder awards for Kentucky-bred horses.

5 Section 23. Incorporation by Reference.

6 (1) The following material is incorporated by reference:

8 2023;



On February 7, 2024, the KQHPAA Advisory Committee met and considered the following request from Revolutionary Racing Kentucky, LLC d/b/a Sandy's Racing & Gaming regarding their 2024 race meet at The Red Mile.

Sandy's race meet will consist of six race days, beginning Sunday, March 17 through Tuesday, March 24, 2024.

Pursuant to 810 KAR 7:060 Section 6, Sandy's is proposing to use of \$60,000 in KQHPAA funds to supplement the purses of six races at their upcoming race meet. These supplements will add \$10,000 per race, paying first through fifth places to eligible Kentucky Quarter Horses who were bred and foaled in Kentucky.

These projections are based on a KQHPAA earned balance of \$720,634 at the end of December 31, 2023, with HHR wagering at Sandy's being the primary driver.

The KQHPAA Advisory Committee along with the Kentucky Quarter Horse Racing Association recommend approval.

Sandy's Racing & Gaming has reviewed our purses and would like to request consideration to add \$10,000 in KQHPAA Development Funds to supplement six qualified KY Bred races for a total draw of \$60,000 in KQHPAA Development Funds. We have based the request on the following information:

1. From April 1, 2023, through December 31, 2023, live on-track wagers totaled \$81,975 with KQHPAA Development Funds of \$810. Simulcasting had \$972 totaled wagered with KQHPAA Development Funds of \$10 and HHR: Total wagers of \$72,063,421 for KQHPAA Development Funds of \$720,634.

On February 1, 2024, the KTDF Advisory Committee considered the following requests regarding Keeneland’s 2024 Spring Race Meet:

The KTDF purse structure will consist of 16 race days beginning Friday, April 5th through Friday, April 26th. Keeneland is proposing KTDF purses in the range of \$5 – \$5.2 million. These projections are based on a KTDF earned balance of \$1.9 million at the end of their 2023 Fall Meet. Keeneland is projecting additional earnings of \$1.6 million to \$1.8 million by the end of their meet with HHR wagering at Keeneland-Red Mile (KRM) being the primary driver along with an additional \$1.5 million to \$1.7 million projected from Oak Grove per their contract. To encourage participation during the meet, Keeneland will pay out KTDF purses through last place to all KTDF eligible horses.

To help Keeneland fund their KTDF purses while increasing the strength of the overall Kentucky Racing Circuitry, Keeneland is also seeking a \$1.25 million dollar transfer from Kentucky Downs.

In accordance with KRS.230.400, Keeneland is also requesting the use of \$106,820 in KTDF to promote, enhance, improve and encourage the further and continued development of the Kentucky Thoroughbred breeding industry in Kentucky.

The KTDF Advisory Committee along with the Kentucky HBPA and the KTA-KTOB recommend approval.

Keeneland has reviewed our KTDF data and would like to offer approximately \$5,000,000-\$5,200,000 in KTDF money for our upcoming Fall meet.

1. We currently have a surplus of \$1,906,660 following the Fall 2023 race meeting;
2. We will conduct 16 days of live racing from April 5th through April 26th on Wednesdays through Sundays;
3. We anticipate KTDF funds to constitute 25.9% of total purses. Breakdown by race type below:
 - a. MSW, ALW, AOC: \$2,912,000 (57.5% of the KTDF allotment)
 - b. CL, MCL, MA, SA: \$652,800 (12.9% of the KTDF allotment)
 - c. Stakes: \$1,500,000 (29.6% of the KTDF allotment)
4. We anticipate a payout percentage of 88.0% of the KTDF carded (\$4,400,000-\$4,576,000 paid);
5. We intend to utilize \$106,820 of KTDF for advertising. Detailed materials regarding the advertising allotment are included;
6. We are projecting Keeneland-Red Mile KTDF earnings from Historical Horse Racing of approximately \$1,600,000-\$1,800,000;
7. We anticipate Oak Grove KTDF earning from Historical Horse Racing of approximately \$1,500,000-\$1,700,000 to be transferred at the conclusion of our race meeting per our contract;
8. We anticipate a KTDF transfer of \$1,250,000 from Kentucky Downs per agreement;

Keeneland remains committed to improving the on-track experience for patrons and is continuously seeking to improve ticketing, food/beverage, customer service, and promotions/events in order to grow our fanbase, and ultimately increase on-track handle. Keeneland has begun its major capital improvement project including a permanent Paddock Building, which will increase capacity and provide new dining options. The project will also update the saddling enclosure to promote horse/horsemen safety. We continue to utilize our BFTologists to increase awareness and engagement with on-track fans to further drive handle. With the opening of sports

wagering, we are excited to improve facilities at Keeneland-Red Mile and plan to encourage patrons to utilize HHR, simulcast, and sports wagering areas.

Keeneland will continue to pay out KTDF funds through last place. A table containing the payout percentage by field size is attached. In the event there is a dead heat for finish positions 1 thru 5, the KTDF percentage payout for each position will be aggregated and paid equally to each horse included in the dead heat. If a non-KTDF eligible horse is involved in a dead heat, those funds will revert to the fund.

We will evaluate the earnings and payout percentages several days into our race meet and may need to make adjustments if our actual earnings and payout percentages are significantly different from our assumptions.

On February 1, 2024, the KTDF Advisory Committee considered the following requests regarding Churchill Downs 2024 Spring Race Meet:

The KTDF purse structure will consist of 43 race days beginning Saturday, April 27th through Sunday, June 30th. Churchill Downs is proposing KTDF purses in the range of \$10.5 – \$11 million. These projections are based on a KTDF earned balance of \$6.7 million by the end of April 2024. Churchill is projecting additional earnings of \$5 million by the end of July with HHR wagering at Derby City and Derby City Downtown being the primary driver. To encourage participation during the meet, Churchill Downs will pay out KTDF purses through last place to all KTDF eligible horses.

In accordance with KRS.230.400, Churchill Downs is also requesting the use of \$200,000 in KTDF to promote, enhance, improve and encourage the further and continued development of the Kentucky Thoroughbred breeding industry in Kentucky.

The KTDF Advisory Committee along with the Kentucky HBPA and the KTA-KTOB recommend approval.

Churchill Downs has reviewed its purses and would like to card KTDF purses in the range of \$10.5 million to \$11.0 million for our upcoming Spring Meet. We have based the range on the following information:

1. At the end of April 2024, Churchill Downs is projecting an ending KTDF earned balance of \$6.7 million.
2. Our 2024 Spring Meet will consist of 43 racing days beginning Saturday, April 27th and ending Sunday, June 30th. We are projecting additional earnings of \$5.0 million by the end of July. The primary driver is the KTDF earned from pari-mutuel wagering from Derby City Gaming LLC ("Derby City") and Derby City Gaming Downtown ("Derby City Downtown") from the beginning of May 2024 through the end of the Spring Meet.
3. We anticipate that KTDF will be approximately 24% of total purses. Of the requested KTDF allotment, we anticipate the following payouts:
 - a. ALW, AOC, SMSW, MDN: approximately 61% of the KTDF allotment
 - b. BCL, CLM, MCL, STR, WMC: approximately 16% of the KTDF allotment; and
 - c. Stakes: approximately 23% of the KTDF allotment
4. For Spring 2024, we are assuming a KTDF payout percentage of 86.5% with anticipated KTDF disbursements of \$9.5 million which is \$0.9 million higher than the \$8.6 million paid during the Spring 2023 Meet. The driver of higher purses paid is additional KTDF added to Stakes races during Derby Week.
5. To encourage participation during the Spring Meet, we are again planning to pay KTDF purses from first to last to all eligible horses.

THE KENTUCKY THOROUGHBRED DEVELOPMENT FUND (KTDF)

Given several years of robust business during the period beginning 2019 through April 2024, the state-of-the-art historical racing machines at nearby Derby City Gaming have generated KTDF for horsemen with Kentucky-sired Kentucky-breds to run for in designated stakes, handicap, allowance, non-claiming maiden races, and allowance optional claiming races with a claiming price of not less than twenty-five thousand dollars (\$25,000) contested at Churchill Downs Racetrack. Continuing in Spring 2024, Churchill Downs Racetrack will offer KTDF money on all claiming races.

Eligible races can be readily recognized in the stakes and condition books by the Kentucky Thoroughbred Development Fund seal, which will appear next to each race in the stakes and condition books.

In accordance with KRS 230.400(5) (d), it is mandatory for a horse to be registered prior to time of entry to be eligible to participate in the distribution of Kentucky Thoroughbred Development Fund monies. Registration is only complete once the application is approved and payment has been received.

All horses of racing age that are both Kentucky-bred and sired by a Kentucky stallion which stood in Kentucky the entire breeding season the year the horse was conceived are eligible to be registered. Owners of horses of racing age are responsible for registering their horses. Stallion owners are responsible for registering their stallions.

Remaining 2% divided among the starters based on the schedule listed above.

Unearned fund monies revert to the Kentucky Thoroughbred Development Fund. Additionally, if a non-KTDF eligible horse is involved in a dead heat, those funds will revert to the fund.

DATE PREFERENCE SYSTEM

The Date System of preference will be used at Churchill Downs as described below:

Foal Certificates and digital foal certificates no longer are required to be on file in the racing office to enter or start at Churchill Downs; however, foal certificates and digital foal certificates must be on file to obtain a preference date and to get a horse tattooed.

Each day's overnight will list the dates of horses in and on the also-eligible list to enable trainers to see what dates are getting horses in over-filled races.

1. In over-filled races, preference will be given to horses in order of their assigned preference dates, earliest date first. Horses having identical dates will be chosen by lot, however, where entry and running dates are the same, the horse with the entry date will have preference.
2. All horses intended for racing at Churchill Downs will be assigned a preference date. Dates assigned will be of two types:
3. **FOR A ZERO DATE** foal papers and digital foal papers must be turned in to the identifier by Tuesday, April 23, 2024.

E-Date

This date will correspond to:

- a) The day on which a horse's foal papers or digital foal papers are submitted to the identifier (the earliest date being the day when entries are first taken for the meeting). An unnamed horse will not receive an E-date.
- b) The day on which a horse is first entered if his papers or digital foal papers are not on file with the identifier.

To qualify for the latter E-date, a horse must have been excluded from a race which appears on the overnight or he must have been entered in a condition book race which failed to fill through insufficient entries.

R-Date

This date will correspond to the day of a horse's most recent race at Churchill Downs. An R-Date will also be assigned to a horse which scratches.

4. A horse retains his R-Date until he receives a newer R-Date. No horse with an established R-Date may receive an E-Date. A horse whose papers or digital papers are removed from the identifier's office will lose his date and must subsequently re-establish a date in order to receive preference. A horse with an E-Date cannot receive a newer E-Date. Horses starting at another race track will forfeit any date they may have at Churchill Downs.
5. Preference dates will consist of two categories: Dirt (D) and Turf (T). Preference dates are good for any type of race or distance.
6. A horse that runs in a race, which has been taken off the turf will retain its turf date. A scratched horse will receive an R-date from the date scratched.
7. When a race is taken off the turf, main track only (MTO) horses will receive an R-Date if they run or scratch. If the race remains on the turf, main track only (MTO) horses will retain their previous date and will not be permitted to start.
8. No E-Date will be assigned to the second choice of an unsplit same-owner entry.

9. A horse which has been placed on a list (veterinarian, steward, starter or paddock judge) will lose their date and be assigned an R-Date corresponding to the day removed from list.
10. A horse which is a scheduled starter in a cancelled race will not receive an R-Date for that race but will retain its previous date.
11. The draw of stakes and handicap race is not subject to date preference.
12. Preference dates are transferred through change of ownership and changes in trainer after the proper transfer procedure have been completed through the Steward's office and delivered to the Racing Secretary's office.
13. Date preference rules will not supersede KHRC rules regarding preference, eligibility or scratches.
14. Winners will be preferred in all non maiden races.

CONDITION PREFERENCE

Horses are preferred by their available conditions in all allowance races beginning with Graded Stakes winners (Grade I-II-III), down through their allowance conditions (when allowance conditions are equal, and open stakes winners shall be preferred) providing the horse has finished 1st, 2nd, 3rd or 4th for \$50,000 or more since starting for less than \$50,000. In allowance/optional claiming races a horse's preference cannot exceed the condition of the race. Starter races for less than \$40,000 will not be preferred.

WINNERS ARE PREFERRED IN ALL NON-MAIDEN RACES.

Also-Eligibles

If there are any scratches in a race with also-eligibles, the also-eligible horses will be permitted to move into the race in the order listed on the overnight.

The stewards may at any time require presentation of a horse's registration certificate, virtual certificate, or racing permit or other proof of ownership.

Upon claim, sale or any other transfer of ownership, the horse's registration certificate or racing permit shall be given to the new owner, and any virtual certificate shall be transferred to the new owner electronically. The new owner shall report the change in ownership to the stewards.

TO RECEIVE A ZERO (0) DATE, foal certificates and digital foal certificates must be on file with the Horse Identifier by Monday, April 1, 2024.

Preference by condition eligibility then by:

1. In over-filled races, preference will be given to horses in order of their assigned preference dates, earliest date first. Horses having identical dates will be chosen by lot, however, where entry and running dates are the same, the horse with the entry date will have preference.
2. All horses intended for racing at Keeneland Association will be assigned a preference date. Dates assigned will be of two types:

E-Date

This date will correspond to:

- a. The day on which a horse's foal papers/digital foal papers and name tag are submitted to the identifier (the earliest date being the day when entries are first taken for the meeting).
- b. The day on which a horse is first entered if his papers are not on file with the identifier.
- c. To qualify for the latter E-Date, a horse must have been excluded from a race which appears on the overnight or he must have been entered in a condition book race which failed to fill through insufficient entries.

R-Date

This date will correspond to:

- a. The day of a horse's most recent race at Keeneland Association.
 - b. An R-Date will also be assigned to a horse which scratches (provided the foal papers are on file with the identifier).

 11. Stakes and handicap races are not subject to date preference.

12. Preference dates are transferred through change of ownership and changes in trainer after the proper transfer procedure have been completed through the Steward's office and delivered to the Racing Secretary's Office.
13. Date preference rules will not supersede KHRC rules regarding preference, eligibility or scratches.
14. Winners will be preferred in all non-maiden races.

Condition Preference

- Horses are preferred by their available conditions in all allowance races beginning with Graded stake winners (Grade I-II-III), open stakes winners through their allowance conditions (when allowance conditions are equal, an open stakes winners shall be preferred) providing the horse has finished 1st, 2nd, 3rd or 4th for \$50,000 or more since starting for less than \$50,000. In allowance/optional claiming races a horse's preference cannot exceed the condition of the race. Starter races for less than \$40,000 will not be preferred.
- No entry will be received except upon the condition that all disputes, claims and objections arising out of the racing or with respect to the interpretation of the conditions of any race shall be decided by the officers of the association, or those whom they may appoint and their decision upon all points shall be final.
- No entry shall be accepted from any stable not provided with a trainer's license.

Main Track Only Entries

- Entries will be accepted in turf races (excluding stakes) for Main Track Only (MTO) horses.
- Trainers must declare the horse as MTO at the time of entry.
- A horse entered as MTO shall be listed as Also-Eligible.
- In an over-filled turf race, an MTO shall not be carded to the exclusion of a turf entry. Also-Eligibles (including MTO) shall be assigned a post position by preference. If preference is equal, post positions shall be drawn by lot, unless otherwise stipulated in the published conditions of the race.
- If the race remains on the turf, a horse listed as MTO shall not be permitted to draw into the race. When a race is removed from the turf, MTO horses will lose any date they have if they run or scratch. If the race remains on the turf, MTO horses will retain their previous date.

The General Fund line includes amounts that are deposited to various accounts. These caps are calculated from deposits resulting from the excise tax for conducting pari-mutuel wagering on historical horse racing. Since these amounts are calculated as a whole and not per licensee, a one-time transfer will be made once the caps are met within the fiscal year. At the end of the fiscal year, approximately \$2M must be deducted from this line in order to determine the actual amount retained by the General Fund. Glossary:

Handle is the total amount wagered for the reporting period, including future bets.

Wagers Settled includes both wagers paid out and wagers resolved for the reporting period.

Winnings is the amount returned to winning players for the reporting period.

Adjusted Gross Revenue (AGR) is the sum of settled wagers collected on all sporting events, less winnings paid and excise taxes paid according to federal law.

Kentucky Excise Tax is tax paid to the state, calculated from AGR at the rate of 9.75% for wagers placed at retail locations and 14.25% for online wagering.
